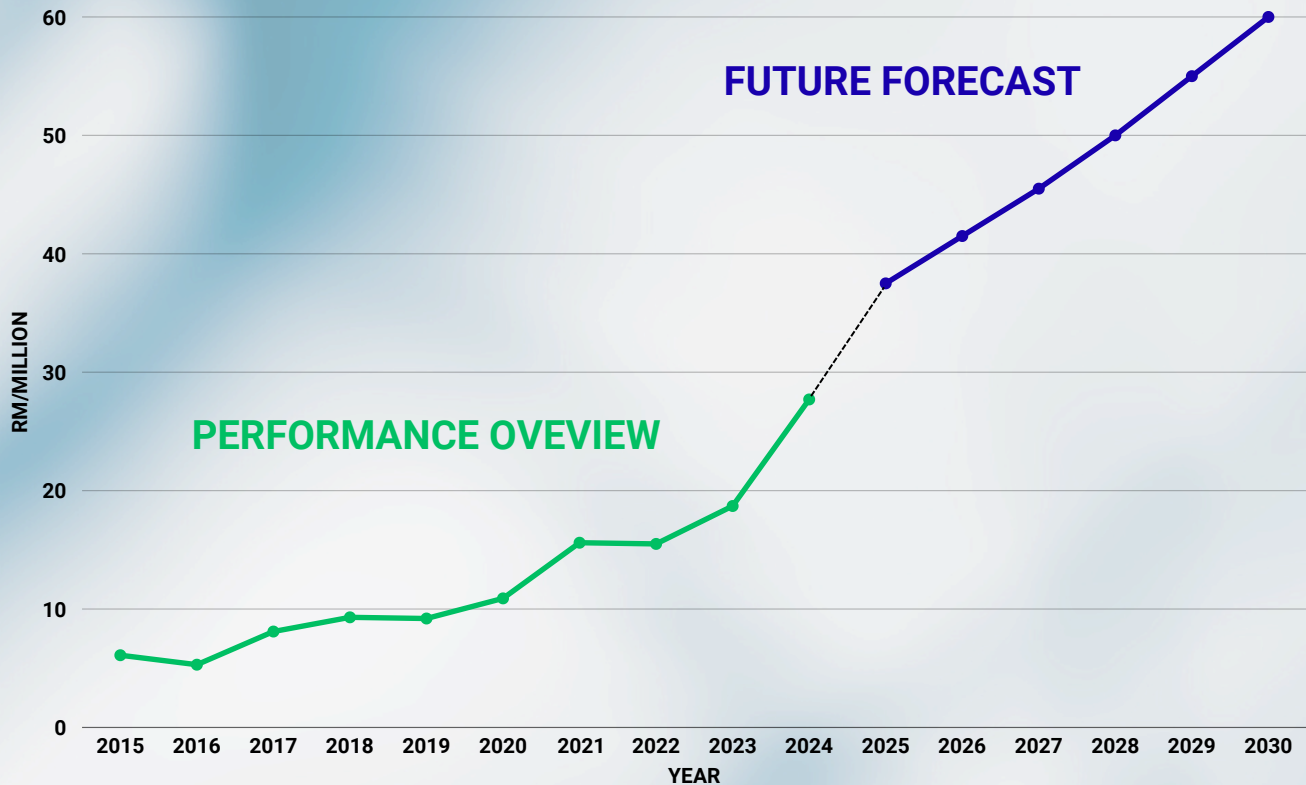

## PERFORMANCE OVERVIEW (2014-2024)
